A Message from the Camp Director:

MASK UPDATE 3/5/21: At this time, we still plan to require campers to wear a mask, should this change we will inform those who are registered.

Dear parents,

Thank you for registering your children for summer camp and continuing to support the Naranjo Museum of Natural History. This year we hope to proceed with the full 8 weeks of camp and will continue to provide a fun and safe camp experience.

Since our camp functions much like a classroom, we have monitored the actions of the local school systems regarding their COVID-19 protocols for their students. We are also following updated protocols and recommendations set by the State of Texas for Day Youth Camp Operations in 2021.

This summer, we are requiring campers to wear masks during camp. Masks must be provided by the parent to ensure a comfortable fit of mask/face shield for the child. Like last year, museum staff/volunteers will be wearing masks and will help make sure campers keep their masks/face shields on. Campers will be able to remove masks while eating and during outdoor play.

We understand the inconvenience these protocols may cause to you and your family, but please trust that these precautions are necessary to create as safe of an environment as possible during the COVID-19 pandemic.

Working together, we can make this a fun and safe experience for campers. We look forward to seeing kids come to camp and take part in the fun activities we have planned.

COVID-19 HEALTH PROTOCOLS FOR PARENTS AND CAMPERS

Please read before registering your child for camp.

Masks

- · Campers are required to wear a mask or face shield during camp.
- Parents will be responsible for providing an appropriate mask or face shield for their child. This will allow flexibility
 for each child to wear a mask that fits their needs, fits properly, and is as comfortable as possible. Adults will also be
 required to wear masks or face shields when in the museum for drop off/pick up.
- Masks/face shields may be removed during lunch breaks or during outdoor play when engaging in appropriate social distancing.

Social Distancing and Crowd Limitations

- The number of campers per week will be limited to 10 campers.
- No more than two campers per classroom table.
- · Teachers and assistants will remind campers to remain separate.
- No partners or group projects.
- Only campers and staff will be allowed in the classroom.
- Museum staff will sign-in for parents during drop off/ and pick up
- Campers will keep a distance from other visitors when in the exhibit hall. Campers will go on exhibit hall tours earlier in the day to avoid potential crowds.

Health Monitoring

- The temperature of all campers will be measured before entering the museum during drop-off; any camper exhibiting a fever of 100.4 or above will be sent home with their parent or guardian. Campers must be without a fever above 100.4 for 24 hours before returning to camp.
- The temperature of all employees will also be measured before entering the museum; any employees exhibiting a fever of 100.4 or above will be sent home. Upon entering the building, employees must wash or sanitize their hands. The museum is also putting extensive health maintenance requirements in place for employees to follow throughout the day.
- Should a camper test positive for covid-19 during or after attending the camps, we ask that parents inform Veronica Amoe immediately by calling 936-404-9202.
- Children showing any visible symptoms will be quarantined with supervision and a parent will be called to pick up their child.

Cleaning and Sanitation

- Upon entering the museum, campers must wash or sanitize their hands.
- Campers will wash or sanitize their hands often throughout the camp day especially before returning to the classroom from exhibit hall tours, bathroom trips, and before/after lunch.
- All staff who engage with campers will wear face masks.
- The museum is installing more hand sanitizing stations and instituting heightened cleaning protocols, including frequent environmental cleaning and disinfection of "high-touch" door handles, and restrooms.
- Camp classrooms will be cleaned and sanitized at the end of each camp day.
- · Campers will have an assigned seat and space in the classroom.
- Campers are encouraged not to share personal electronic devices. Electronic devices cannot be used during the camp curriculum portion of the day.
- In order to create a possible "low touch" Before and After camp environment we will eliminate touch items like board games and building sets from the room. This summer we will provide coloring pages and activity sheets to younger campers and screen short movies for all ages. All campers will be permitted to use personal electronic devices during the extended day periods. Campers will be encouraged not to share personal electronic devices.

How to Register for Camp

To register your child for summer camp, you must submit a registration form along with full payment for each week your child plans to attend.

NEW IN 2021:

There are now separate registration forms for members and non-members. If you are a museum member, you will complete the membership form, if you are not a museum member, you will complete non-member form. Health care forms are the same for members and non-members.

This change is to further organize admission process.

Registration Forms

<u>One Registration Form and one Health Care Form</u> should be completed for each child you are registering for camp. All sections of the registration form and health care form should be completed including release signatures. Registration is not complete without payment and completed forms. Your child's camp place will not be saved without a completed registration.

Please note when sending forms electronically: Signatures must be hand-written, digital signatures typed out on a computer or device will be considered valid.

Payment

To complete registration, you must <u>pay full amount</u> for each week your child is registered for. Payment can be taken overthe-phone. The Naranjo Museum accepts: Mastercard, visa, discover, cash or check.

At the Museum

You may register your child at the museum, we have forms available and you can pay at that time. Check www.naranjomuseum.org for hours.

<u>Email</u>

You can print off a registration form online and submit it via email. This can be done by either scanning the registration form or taking a very clear photo of it using your smart phone. Most smartphones have a "files" app that allows you to scan documents and store as a pdf file on your phone that you can then email.

Registration forms need to be emailed to Veronica Amoe at veronica@naranjomuseum.org.

Once the form is received, you will be called for payment and emailed your conformation after payment. If you are not contacted within 2 business days, check email address and if it is correct, call Veronica Amoe at (936)-404-9202.

Cancellations/Refunds

Due to high demand for camp positions, there are no full refunds for completed camp registration. To receive a 50% refund, you need to email a cancellation request to Veronica Amoe at veronica@naranjomuseum.org *10 days or more before the starting date of your camp week*. You will not receive a refund if you cancel less than 10 days before the starting date of your camp week.

COVID-19-related Cancellations:

COVID-19-related cancellations/refunds will be processed on case-to-case basis.

Camp Times

Camps are Monday-Friday 10am-3pm. (With the exception of week 1, which is Tuesday-Friday)

Camp Ages

Your child must be at least 6 years old and must be going into 1st-6th grade<u>as of fall 2021</u> to participate in Naranjo Museum Summer Camps. Camp weeks are separated by age groups (1st-3rd) or (4th-6th) according to the grade they are entering in the fall. There are <u>10 camp positions</u> available per week. Register early to ensure a place for your child.

Drop off/Pick Up

All parents entering the building to drop off or pick up will be required to wear a mask. For pick up parents will need to show a photo id to pick up their child.

In place of a sign in, camp staff will keep track of drop off/pick up digitally.

Camp Descriptions

NEW All Things Animals (going into 1st-3rd grade)

Animals are a huge part of Earth History! Campers will look at animals from the past and present and how they impact the environment around them. Campers will learn more about animals and how to take care of their animals at home! Live animal warning: We are going to try to have some live animals brought in for this camp week, including but not limited to a domesticated dog. If your child is allergic or fearful of any kind of animals, you might need to choose another camp week.

NEW STEM WEEK (going into 4th-6th grade)

Science experiments, building, creative problem solving and more! Campers will explore various areas of Science, Technology, Engineering and Math!

Dinosaur Discovery

Campers will dive into the world of dinosaurs! They will learn the names of dinosaurs, what makes each one special and how scientists learn about dinosaurs. Campers will take part in fun crafts and activities that will bring to life dinosaur learning.

Junior Paleontologist

Campers will take part in dig simulations, will learn what skills paleontologists use to help them find dinosaurs and how they know where to look. They will look into the different groups of dinosaurs and how they are categorized. Campers will learn through crafts, team exercises and games.

Space Exploration

Take off into space! Campers will do crafts that will help them learn more about the stars and planets! Campers will play games, conduct space experiments and mission simulations.

Ancient Arts & Crafts

Campers will explore the world and look at different techniques for creating art by studying ancient civilizations. Campers will use unique approaches to painting, sculpting and more!

Morning/Afternoon Care

Morning Care and Afternoon Care is available for children who need to arrive before 10am and stay after 3pm. Campers will be cared for by camp staff. Campers may play games, watch a movie and socialize during morning and afternoon care.

Morning Care

For morning care, campers will check in and be in the classroom till around 8:30am. Morning camp will take place in the classroom. Children will be able to play with toys/devices that they bring at their table and a movie will be played.

Afternoon Care

For afternoon care, children will be in the classroom. Children will be able to play with toys/devices that they bring at their table and a movie will be played.

<u>Snacks</u>

Snacks will no longer be provided by camp. Campers in morning/afternoon care will need to bring their own snacks and drinks.

FAQs for Morning and Afternoon Care:

Q: What if I only need morning/afternoon care for one day? A: If you only need morning/afternoon care for one day, you must pay the price for the full week.

Q: If I am not preregistered for morning/afternoon care, can I add it on later?

A: Yes, as long as you notify the camp director (Veronica Amoe) and pay the price for care, no later than the Friday before your camp week starts.

Drop Off/Sign In starting at 9:45am

- Parents will be required to wear a mask for drop off and pick up.
- In place of a sign in sheet, camp staff will be tracking this information digitally.
- Each camper will have their temperature taken before entering the classroom.
- Campers running a temperature higher than 100.4 degrees will not be permitted to stay for camp.
- Campers showing symptoms listed by the State of Texas will not be permitted to stay at camp.
- Parents will be asked to provide the following information upon drop off: Your name, the name of the person dropping off, verification that your child has not shown any symptoms of covid-19 or been tested positive for covid-19, verification that no persons living with the child have tested positive for covid-19 or shown symptoms for covid-19, verification that your child has not been exposed to anyone who has tested positive for covid-19 within 2 weeks prior to camp.
- Campers may not enter the classroom until the sign-in process is complete.
- Parents may not enter the classroom.
- Parents waiting to drop off need to keep a 6ft distance from other parents.

Pick up/Sign out 3:00pm

- Campers must be picked up from the classroom.
- Camp staff will need to verify the person picking up matches the name given during drop off.
- Parents picking up must show photo id.
- Unless you are registered for afternoon care, your child must be picked up no later than 3:15pm.

Camp Supervision: Camps are instructed and supervised by qualified staff and volunteers. All museum staff and volunteers have been through extensive background checks and training.

Camp Shirt : Camp shirts are not available for summer 2021.

Check In/Check Out: See sign in/sign out page.

Lunches: Parents need to pack their children a sack lunch, a couple of snacks and plenty of water. If your child does not have a lunch, the parent is responsible for bringing the child a lunch to the museum by 11:45am. Lunches brought to children will need to be dropped off in the ticket office.

Clothing: Campers are asked to wear comfortable clothes and shoes that can get messy. Closed-toe shoes are recommended for outside play. Campers are required to bring a mask and will be asked to wear them inside the museum.

Toys/Electronics: Toys and electronics are permitted for children to use during free time or before/after care. The Naranjo Museum and staff are not responsible for any loss or damages to anything sent with your child. Campers may not share devices or toys with other campers.

Outside Play: Campers are taken outside after lunch for supervised playtime. Temperatures are closely monitored and children are not taken outside during particularly hot days. Children are encouraged to wear sun screen to protect their skin from the sun.

Cancellation Policy: Due to high demand for camp positions, there are no full refunds for completed camp registration. To receive a 50% refund, you need to email a cancellation request to Veronica Amoe at veronica@ naranjomuseum.org *10 days or more before the starting date of your camp week*. You will not receive a refund if you cancel less than 10 days before the starting date of your camp week. Covid-19 related cancellations will be dealt with on a case-to-case basis.

Medical Policy: Museum staff are only permitted to administer basic first aid to children unless otherwise stated in the child's medical information on registration form. Parents will be called should children feel ill, children running fever or throwing up will be asked to be picked up. In the event of a medical emergency, assistance may be called from A Pineywoods Home Health company (next door to the museum). If necessary, 911 will be called and first response will take children to the closest hospital. *At this time, we are unable to accommodate children with special medical, behavioral and/ or mental needs.*

Camp Rules/ Discipline Policy: Camp rules are explained the first day of camp and are gone over throughout the week. Camp rules are: Be kind to each other, be respectful to the teacher, museum visitors and museum property, participate in lessons and activities and of course have fun. Camp rules are explained with an emphasis on choices and communication. Should a child's choices cause continued disruption or harm to the other campers, you will be asked to pick up your child. You may bring them back the following day should you choose, however, if a camper's choices compromise the safety and well being of the other campers, your child may be asked to not return to camp. There are no refunds for camper dismissal as a result of poor discipline. If your child does not choose to cause harm to other campers, but their behavioral patterns/choices continue to distract or disrupt campers or camp activities, you may be asked to pick up your child. There is not enough camp staff to care for campers one-on-one. If you have any questions regarding behavioral expectations after reading camp information, please contact Veronica Amoe at veronica@naranjomuseum.org. With new health precautions, it is even more important that a child is able to listen and follow directions given by camp staff.

Frequently Asked Questions

How can I guarantee my child gets into the camp they want? There are limited camp weeks and camp spots (10 campers per camp). To guarantee your child gets into camp, register them as soon as possible. Museum Members can register 2 weeks before the information is released to the public.

What changes are being made in response to COVID-19? Please read the "COVID-19 Health Protocols" page to see changes.

What information has the museum used to plan health protocols? State of Texas Health Protocols for Museums and Day Camps, CDC information for camps, other museum protocols (HMNH, MFAH, DSP), American Camp Association and protocols set by school/daycare systems.

Can I bring lunch to my child? Can I stay and eat lunch with them? Yes, but the lunch will need to be left in the ticket office. Parents are not permitted in the classroom.

How to I contact my child during camp? You should first call (936)-639-3466 to get in touch with the museum who will inform camp teachers. If it is an emergency, you may contact Veronica directly at (936)-404-9202.

Can I come to camp to give my child needed medication? Absolutely, as we are not allowed to administer medication to children, you are welcome to come and give your child medicine. Please inform of us the schedule on Health Care Form, or for unscheduled medicine, you may call the museum ahead of time. We will bring the camper to you, please do not enter the classroom.

Are movies shown at camp? How are movies selected? Movies are mostly shown during morning drop off times and lunch. Movies are not shown during instructional time. Movies are selected based on relevance to the week's topic and viewing age group.

Are all the weeks different? Each themed camp week is different from the other themed camp weeks.
